PLEASE TAKE NOTICE that on April 20, 2021 (the "**Petition Date**"), WB Supply LLC (the "**Debtor**") filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code (the "**Chapter 11 Case**") with the United States Bankruptcy Court for the District of Delaware (the "**Court**").

PLEASE TAKE FURTHER NOTICE that on June 18, 2021, the Court entered an order (the "**Bar Date Order**") establishing **July 30, 2021 at 5:00 p.m. (prevailing Eastern Time)** (the "**General Bar Date**") as the last date and time for each person or entity to file a proof of claim in the Chapter 11 Case (the "**Proof of Claim**" or "**Proofs of Claims**," as applicable); *provided that*, solely with respect to a governmental unit, the last date and time for such governmental unit to file a Proof of Claim in the Chapter 11 Case is **October 27, 2021 at 5:00 p.m. (prevailing Eastern Time)** (the "**Governmental Bar Date**," and together with the General Bar Date, the "**Bar Dates**").

Pursuant to the Bar Date Order, each person or entity (including, without limitation, each individual, partnership, joint venture, corporation, estate, and trust) that holds or seeks to assert a claim (as defined in section 101(5) of the Bankruptcy Code) against the Debtors that arose, or is deemed to have arisen, prior to the Petition Date (including, without limitation, claims entitled to administrative priority status under section 503(b)(9) of the Bankruptcy Code), **MUST FILE A PROOF OF CLAIM** on or before **5:00 p.m. (prevailing Eastern Time)**, on **July 30, 2021** (the "**General Bar Date**"), by sending an original proof of claim form to Stretto² ("**Stretto**"), at the following address: WB Supply LLC Claims Processing, c/o Stretto, 410 Exchange, Suite 100, Irvine, California 92602, or by completing the online proof of claim form available at <https://cases.stretto.com/WBSupply>, under Tab "File a Claim" so that it is **actually received** on or before the General Bar Date; *provided that*, solely with respect to governmental units (as defined in section 101(27) of the Bankruptcy Code), the deadline for such governmental units to file a proof of claim against the Debtor is **October 27, 2021 at 5:00 p.m. (prevailing Eastern Time)** (the "**Governmental Bar Date**"). Proofs of claim must be sent by overnight mail, courier service, hand delivery, regular mail, or in person, or completed electronically through Stretto's website. Proofs of claim sent by facsimile, telecopy, or electronic mail will **not** be accepted and will **not** be considered properly or timely filed for any purpose in these Chapter 11 Case.

ABSENT FURTHER ORDER OF THE COURT, ANY PERSON OR ENTITY THAT IS REQUIRED TO FILE A PROOF OF CLAIM IN THE CHAPTER 11 CASE WITH RESPECT TO A PARTICULAR CLAIM AGAINST THE DEBTOR, BUT THAT FAILS TO DO SO PROPERLY BY THE APPLICABLE BAR DATE, SHALL NOT BE TREATED AS A CREDITOR IN THE CHAPTER 11 CASE WITH RESPECT TO SUCH CLAIM FOR PURPOSES OF VOTING AND DISTRIBUTION; PROVIDED, HOWEVER, THAT A HOLDER OF A CLAIM SHALL BE TREATED AS A CREDITOR FOR PURPOSES OF VOTING AND DISTRIBUTION AS TO ANY UNDISPUTED, NONCONTINGENT, AND LIQUIDATED CLAIMS IDENTIFIED IN THE SCHEDULES ON BEHALF OF SUCH HOLDER IN THE AMOUNT SET FORTH IN THE SCHEDULES.
